**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That**      **JOHN C. PORTER**

of 1324 Park Rose Avenue, Duarte, State of California, has made application to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Wolf Creek a tributary of Grave Creek for the purpose of irrigation under Permit No. 18841 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 14, 1949

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.008 cubic feet per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$  NE $\frac{1}{4}$ , Section 22, Township 33 South, Range 6 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $4\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season from April 2, to October 31, of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.0 acres in NE $\frac{1}{4}$  NW $\frac{1}{4}$   
 0.6 acres in NW $\frac{1}{4}$  NE $\frac{1}{4}$   
 Section 22  
 Township 33 South, Range 6 West, W. M.

Land on which water is to be used is part of that described as follows: Beginning at a point in Section 22, T. 33 S., R. 6 W., W. M., Josephine County, Oregon from which the Quarter Section corner between Sections 15 and 22 bears North 52° East, three and 11/100 chains distant, running thence South 16° 30' East, nine and 94/100 chains to Wolf Creek; thence Northeasterly along Wolf Creek six and 45/100 chains to the County Road; thence North 16° 30' West, five and 36/100 chains; thence West, five and 94/100 chains to the place of beginning and known as the Hotel Property, and containing 4.45 acres, more or less. (Less to Highway)

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
