irrigation under Permit No. of the State Engineer, and that said right to the use of said waters 17135 has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 8, 1946.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.15 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the $SW_4^{\frac{1}{4}}$ $SW_4^{\frac{1}{4}}$, Section 24, Township 13 South, Range 28 East. W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.8 acres in the NW1 NE1	1.0 acres in the NW1 NW1

Township 13 South, Range 28 East, W. M. Land on which water is to be used is a part of that described as follows:

Beginning at a point 12 chains South of the NE corner of Section 23 thence West 24 chains thence South 20 chains thence East 33 chains thence South 32 chains thence East to Field Creek, thence downstream along Field Creek to a point 12 chains South of the North line of Sec. 29 thence West to the place of beginning. Within the East $\frac{1}{2}$ of Sec. 23 and West $\frac{1}{2}$ Sec. 24, Township 13 South, Range 28 East. W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of

use herein described.
