This Is to Certify, That JAMES ROBERT & GEORGIE LORAYNE GIVENS

of Rt. 3. Box 899, Albany , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Calapooia River

a tributary of Willamette River Irrigation

for the purpose of

under Permit No. 20780 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 28, 1951,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.331 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW_+^1 SE_+^1 . Section 23. Township 11 South, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.5 acres in the NE¹₄ SW¹₄
14.3 acres in the SE¹₄ SW¹₄
1.2 acres in the NW¹₄ SE¹₄
9.3 acres in the SW¹₂ SE¹₄
Section 23
0.2 acres in the NW¹₄ NE¹₄
1.0 acres in the NE¹₄ NW¹₄
Section 26

Township 11 South, Range 4 West, W. M.

Land on which water is to be used is a part of that described as follows: Beginning at a point in the center of County Road 25 ch. N. and 43.53 ch. E. of the SW corner of D.L.C. No. 78, T. 11 S., R. 4 W., W. M.; thence E. 27.3 ch. to the center of Calapooya River; thence down the river 53.05 ch. more or less; thence N. 71° 30' W. 3.71 ch. to the center of the county road; thence following road S. 27° 15' W. 35.24 ch. to place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
