of Route 1, Box 180, Sheridan , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Mill Creek

a tributary of Yamhill River

for the purpose of

irrigation under Permit No. 16406 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 12, 1945,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 9.248 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE_{+}^{\downarrow} NW_{+}^{\downarrow} , as projected within Blair D.L.C. no. 41, Section 21, Township 6 South, Range 6 West, W. M.
