of Kanhatten Beach , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed stream

a tributary of Pacific Ocean

for the purpose of

domestic use for one family

under Permit No. 16876 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 29, 1946.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW_+^1 NE_+^1 , Section 20, Township 2 North, Range 10 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to _____ of one cubic foot per second per acre,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be used is a part of that described as follows:

Being part of the SW; of the NE; of Sec. 20, T. 2 N., k. 10 W., W. M. Beginning at the SW corner of tract No. 2658 as described in deed to Anna H. Novdast, recorded in book 62 at page 153 secords of Deeds of said county and state running thence South easterly following the south line extended of the Novdast tract 200 feet; thence southwesterly at right angles to the above line 100 feet; thence northwesterly parallel with the south line of the Novdast tract 200 feet to the east line of the highway; thence northeasterly along said highway 100 feet to the place of beginning.

Novdast tract—Book, 62 page 153 records of deeds of Tillamook County Beginning at the initial point of Nedonna which is North 7° 30' East 1046 feet from the Northwest corner of the Southwest quarter of the Southeast quarter of Sec. 20, Township 2 North, Range 10 West, W. M., and go thence North 22° 9' East until this course coincides with the East line of the highway which is twenty feet from and parallel to the center line of the highway, follow this East line of the highway until a distance of 790 feet from the initial point of Nedonna is reached which is the Southwest corner of the tract conveyed to Anna H. Novdast and also the initial point of the tract described in question No. 8 above

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
