**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** PAUL BOLLMAN

of 811 Court Street, Dallas, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Rickreall Creek a tributary of Willamette River for the purpose of domestic, including the irrigation of not to exceed  $\frac{1}{2}$  acre domestic lawns and under Permit No. 18023 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 9, 1947.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 1 (NE $\frac{1}{4}$  NW $\frac{1}{4}$ ), Section 36, Township 7 South, Range 6 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to - - - - - of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Domestic,  $\frac{1}{2}$  acre in the NE $\frac{1}{4}$  NW $\frac{1}{4}$ , as projected within L. G. Tuttle D.L.C. No. 42  
Section 36  
Township 7 South, Range 6 West, W. M.

Land on which water is to be used is a part of that described as follows:

Beginning at an iron pipe on the West line of the L. G. Tuttle D.L.C., No. 42, at the NW corner of Tract 1 in Lauterman's LaCreole Summer Home Tracts, in T. 7 S., R. 6 W., W. M., in Polk County, Oregon; and running thence North 0° 30' West 35.0 feet to an iron pipe; thence South 89° 30' West 121.94 feet; thence South 6° 38' East 214.23 feet to a point from which an Iron Pipe bears North 89° 30' East 99.05 feet; thence North 89° 30' East 225.91 feet to an Iron Pipe on the West line of the County Road; thence along the arc of a 409.3 foot radius curve to the right a distance of 179.74 feet to an Iron pipe (the Long Chord of said arc bears N. 2° 32' W. 178.1 feet); thence South 89° 30' West 120.54 feet to the place of beginning and containing 1.039 acres, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
