CERTIFICATE OF WATER RIGHT

This Is to Certify, That HAROLD CROUCH

of Star Route, Oakland, State of Oregon 97462, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Calapooya Creek a tributary of Umpqua River for the purpose of irrigation under Permit No. 18106 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 26, 1948,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.02 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW 1/4 NW 1/4, Section 27, SW 1/4 SW 1/4, Section 22, both as projected within J. T. Daniel D.L.C. No. 44, Township 25 South, Range 6 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 2.0 acres in the NW 1/4 SW 1/4, as projected within J. T. Daniel D.L.C. No. 44
- 1.0 acres in the NE 1/4 SW 1/4, as projected within J. T. Daniel D.L.C. No. 44
- 14.4 acres in the SE 1/4 SW 1/4, as projected within J. T. Daniel D.L.C. No. 44
- 27.8 acres in the SW 1/4 SW 1/4, as projected within J. T. Daniel D.L.C. No. 44
- Section 22
- 2.55 acres in the SE 1/4 SE 1/4, as projected within J. T. Daniel D.L.C. No. 44
- Section 21
- 17.2 acres in the NE 1/4 NE 1/4, as projected within J. T. Daniel D.L.C. No. 44
- Section 28
- 15.0 acres in the NW 1/4 NW 1/4, as projected within J. T. Daniel D.L.C. No. 44
- 1.6 acres in the NE 1/4 NW 1/4, as projected within J. T. Daniel D.L.C. No. 44

Land on which water is to be used is a part of that described as follows: SW 1/4 NE 1/4 SW 1/4, SE 1/4 NW 1/4 SW 1/4, SW 1/4 SW 1/4, W 1/2 SE 1/4 SE 1/4, all in Sec. 22; that part of the N 1/2 NE 1/4 NW 1/4 in D.L.C. 44, That part of the NW 1/4 NW 1/4 lying West of Calapooya Creek. All in Sec. 27, R 3/4 NE 1/4 NE 1/4 Sec. 28, all within J. T. Daniel D.L.C. 44, T. 25 S. R. 6 W.W.M. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
