CERTIFICATE OF WATER RIGHT

This Is to Certify, That ERNEST W. and FRONA MAE TIMMONS

of Route 1, Box 26, Holley, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Calapooya River a tributary of Willamette River for the purpose of irrigation, domestic and stock under Permit No. 19507 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 22, 1950.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.054 cubic foot per second, being 0.044 c.f.s. for irrigation; and 0.01 c.f.s. for domestic and stock.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ SE $\frac{1}{4}$. As projected within Timothy Riggs D.L.C. No. 39, Section 7, Township 14 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.6 acres in the SE $\frac{1}{4}$ SW $\frac{1}{4}$, as projected within Timothy Riggs D.L.C. No. 39
1.9 acres in the SW $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within Timothy Riggs D.L.C. No. 39
Section 7
Township 14 South, Range 1 West, W. M.

Land on which water is to be used is a part of that described as follows:

Part of Timothy A. Riggs D.L.C. No. 39, T. 14 S., R. 1 W., W. M., more particularly described as beginning on the North line of a 15 acre tract conveyed by W. R. Hendricks to S. L. Reese by deed recorded September 18, 1947 in Book 195; page 690. Deed Records, said beginning point being 15 chains east of a point 13.47 chains south of the Northwest corner of said DLC; thence North 10 chains; thence East 3.50 chains; thence South 10 chains to the aforementioned North line of the Reese tract; thence West 3.50 chains to the place of beginning; SUBJECT to the right of public in roads; all being and lying in Linn County, Oregon

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
