has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from April 16, 1951.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.217 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the SW4 NE. as projected within Elias L. Walter

D.L.C. No. 38, Section 36, Township 13 South, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year.

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 0.8 acres in the NW; NE; as projected within Elias L. Walter D.L.C. No. 38
- 9.0 acres in the SW NE, as projected within Elias L. Walter D.L.C. No. 38
- 6.5 acres in the SW; NE; as projected within Alexander Kirk D.L.C. No. 37
- 0.1 acres in the SE_{4}^{1} NE_{4}^{1} , as projected within Alexander Kirk D.L.C. No. 37
- 0.9 acres in the SE; NW; as projected within Elias L. Walter D.L.C. No. 38
 Section 36

Township 13 South, Range 3 West, W. M.

Land on which water is to be used is a part of that described as follows:

Beginning at a point 17 chains south of the NW corner of Alexander Kirk

D.L.C. No. 37. thence West 13 chains, thence South 20 chains thence East 22 chains thence North to the NE corner SW. NE. Sec. 36, thence Northwesterly to the place of beginning being within Sec. 36, T. 13 S., R. 3 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
