**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That**      STANLEY M. and ELDORA P. BETZ

of Route 1, Brownsville, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Calapooya River, a tributary of Willamette River, for the purpose of irrigation under Permit No. 20451 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 24, 1951,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.109 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$  NE $\frac{1}{4}$ , as projected within James R. Templeton D.L.C. No. 52, Section 11, Township 14 South, Range 2 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

7.5 acres in the NW $\frac{1}{4}$  NE $\frac{1}{4}$ , as projected within James R. Templeton D.L.C. No. 52  
1.2 acres in the SW $\frac{1}{4}$  NE $\frac{1}{4}$ , as projected within James R. Templeton D.L.C. No. 52  
Section 11

Township 14 South, Range 2 West, W. M.

Land on which water is to be used is a part of that described as follows:

Beginning in the center line of a county road, on the Donation Land Claim of James R. Templeton, Not. No. 2613 in T. 14 S., R. 2 W., W. M., Oregon, 10.63 chains more or less, North of a point in the South line of and East 25.58 distant from the SW corner of said Claim; and running from said place of beginning North 22.72 chains to the Calapooya River; thence North 78° 45' East up said River 5.63 chains to a point therein North of a point in the South line of and 31.10 chains distant from the SW corner of said Claim; thence South 28.54 chains to the center line of said road, thence Northerly along the center line of said road 7.26 chains, more or less, to the place of beginning, and containing 14.15 acres, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
