**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** GEORGE D. RICE.

of Route 2, Box 487, Grants Pass, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Pickett Creek a tributary of Rogue River for the purpose of irrigation under Permit No. 21155 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 4, 1952.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.079 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$  NE $\frac{1}{4}$ , Section 26, Township 35 South, Range 7 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

4.5 acres in the SW $\frac{1}{4}$  NE $\frac{1}{4}$   
1.8 acres in the NW $\frac{1}{4}$  SE $\frac{1}{4}$   
Section 26

Township 35 South, Range 7 West, W. M.

Land on which water is to be used is a part of that described as follows:

Beginning at the SW corner of Gov. Lot 5 in Sec. 26 T. 35 S., R. 7 W., W. M., running thence E., along the S. line of Gov. Lot 5, 60 ft. to Rogue River; thence S. 2° W. along the River 258 ft; thence S. 75° W. to a point on the center line of the road; thence N. 46° 46' W. along the road 472.85 ft. to a point where said road intersects the E. and W. center line of Sec. 26; thence E. to beginning. Tax Lot 6. Beginning at the SE corner of the SW $\frac{1}{4}$  NE $\frac{1}{4}$  of said Sec. 26; thence running W. along the S. line of the SW $\frac{1}{4}$  NE $\frac{1}{4}$  to the center of Sec. 26; thence N. along the N. and S. center line of Sec. 26; 1050 ft. to the center of Pickett Cr. thence SE'ly following channel of Pickett Creek approximately 1650 ft. to a point on the E. line of the SW $\frac{1}{4}$  NE $\frac{1}{4}$  of Sec. 26; thence S. 65 ft. to beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
