of Route 2, Box 28, Konmouth , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Big Luckiamute River and Little Luckiamute River a tributary of Willamette River

for the purpose of

under Permit No. of the State Engineer, and that said right to the use of said waters 18326 has been perjected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 29, 1948,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.80 cubic foot per second, being 0.61 c.f.s. from Big Luckiamute River, and 0.19 c.f.s. from Little Luckiamute River,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW1 NW1. as projected within Musick D.L.C. No. 58, Section 15, and the SE_{π}^{1} , SE_{π}^{1} , as projected within Gilliam D.L.C. No. 57, Section 16, Township 9 South, Range 5 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 21 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform - such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

From Little Luckiamute River

- 6.7 acres in the E_2^1 NE¹ NE¹, as projected within Musick D.L.C. No. 58 Section 16

From Big Luckiamute River
