CERTIFICATE OF WATER RIGHT

This Is to Certify, That ARTHUR R. and HELEN N. QUACKENBUSH

of 1995 Potter Street, Eugene , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of McKenzie River, and unnamed pond a tributary of for the purpose of

irrigation

under Permit No. 19480 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from Lay 3, 1950,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and ... I not exceed 0.55 cubic foot per second, being 0.45 c.f.s. from river and 0.10 c.f.s. from pond,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 2 (NW_{+}^{1}), Section 28 and Lot 11 (SE_{+}^{1} NE_{+}^{1}), Section 29. Township 17 South, Range 2 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 0.8 acres in Lot 1 (NE + NW +)
- 11.0 acres in Lot 2 (NW NW)
- 3.6 acres in the Swin NWin, as projected within A. Powers D.L. C. No. 49
 Section 28
- 6.0 acres in Lot 11 (NE1 NE1)
- 19.0 acres in Lot 11 (SE NE NE 1)
- 2.0 acres in Lot 10 ($SW_4^{\frac{1}{4}}$ $NE_4^{\frac{1}{4}}$)
- 6.6 acres in the SE NEt. as projected within A. Powers D. L. C. No. 49
 Section 29

Township 17 South, Range 2 West, W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
