CERTIFICATE OF WATER RIGHT

This Is to Certify, That GLENN F. ISOM and ELIZABETH M. ISOM

of Route 1, Brownsville, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Calapooya River a tributary of Willamette River for the purpose of irrigation under Permit No. 20362 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 28, 1951,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.374 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$ NW $\frac{1}{4}$, as projected within Elias L. Walter D.L.C. No. 38, Section 36, Township 13 South, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

9.5 acres in the SW $\frac{1}{4}$ NW $\frac{1}{4}$
4.1 acres in the NW $\frac{1}{4}$ SW $\frac{1}{4}$
2.0 acres in the SE $\frac{1}{4}$ NW $\frac{1}{4}$
14.3 acres in the NE $\frac{1}{4}$ SW $\frac{1}{4}$
All as projected within Elias Walter D.L.C. No. 38
Section 36
Township 13 South, Range 3 West, W. M.

Land on which water is to be used is a part of that described as follows:

E 3/4 of SW $\frac{1}{4}$ NW $\frac{1}{4}$ lying South of the Calapooya River, SW $\frac{1}{2}$ of SE $\frac{1}{4}$ NW $\frac{1}{4}$ lying South of the Calapooya River, N 3/4 of NE $\frac{1}{4}$ SW $\frac{1}{4}$, N $\frac{1}{2}$ of NW $\frac{1}{4}$ SW $\frac{1}{4}$.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
