ofRoute 2, Bax 612, Creswell , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Clear Creek

a tributary of Middle Fork Willamette River

for the purpose of

irrigation under Permit No. 16913

of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby November 2, 1945, confirmed dates from

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.375 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE 1_4 SE 1_4 , as projected within Barclay D.L.C. No. 52, Section 26, Township 18 South, Range 2 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable retation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

5.0 acres in the W_2^1 NW_4^1 SW_4^1 , as projected within Barclay D.L.C. No. 52 Section 25

3.0 acres in the S_{\pm}^{1} SE_{\pm}^{1} NE_{\pm}^{1} , as projected within Barclay D.L.C. No. 52

28.8 acres in the NE: SE: as projected within Barclay D.L.C. No. 52

1.6 acres in the $N_4^{\frac{1}{4}}$ SE $_4^{\frac{1}{4}}$ SE $_4^{\frac{1}{4}}$, as projected within Barclay D.L.C. No. 52 0.1 acres in the $N_2^{\frac{1}{2}}$ SE $_4^{\frac{1}{4}}$ SE $_4^{\frac{1}{4}}$, as projected within A. Bristow D.L.C. No. 67 Section 26

Township 18 South, Range 2 West, W. K.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
