CERTIFICATE OF WATER RIGHT

This Is to Certify, That CHARLES L. SIM

of Route 3, Box 913, Albany, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Calapooya River, a tributary of Willamette River, for the purpose of irrigation under Permit No. 17061 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 22, 1946

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.48 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$ NW $\frac{1}{4}$, as projected within Jarvis Briggs D.L.C. No. 83, Section 24, Township 11 South, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 12.4 acres in the SE $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within Jarvis Briggs D.L.C. No. 83
Section 14
- 9.0 acres in the NE $\frac{1}{4}$ NE $\frac{1}{4}$, as projected within Jarvis Briggs D.L.C. No. 83
Section 23
- 5.0 acres in the NW $\frac{1}{4}$ NW $\frac{1}{4}$, as projected within Jarvis Briggs D.L.C. No. 83
Section 24
- 12.1 acres in the SW $\frac{1}{4}$ SW $\frac{1}{4}$, as projected within Jarvis Briggs D.L.C. No. 83
Section 13

Township 11 South, Range 4 West, W. M.

Land on which water is to be used is a part of that described as follows:

Those parts of the S $\frac{3}{4}$ SE $\frac{1}{4}$ SE $\frac{1}{4}$, Sec. 14, and N $\frac{1}{2}$ NW $\frac{1}{4}$ NW $\frac{1}{4}$, Sec. 23, lying East of the County Road and those parts of the S $\frac{3}{4}$ SW $\frac{1}{4}$ SW $\frac{1}{4}$, Sec. 13, and N $\frac{1}{2}$ NW $\frac{1}{4}$ NW $\frac{1}{4}$, Sec. 24 lying East of Calapooya River all in T. 11 S., R. 4 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
