that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.62 cubic foot per second.

30.0 acres in the NW1 NE4, as projected within M. Vallis D.L.C. No. 40 ll.2 acres in the SW1 NE4, as projected within M. Wallis D.L.C. No. 40 Section 34

Township 17 South, Range 4 West, W. M.

Land on which water is to be used is a part of that described as follows:

Beginning 22.425 chains N. 89° 30' W. from the SE corner of M. Wallis D.L.C. No. 40 in T. 17 S., R. 4 W., W. M., thence N. 89° 30' W. 15.415 chains, thence N. 13' E. 35 chains thence S. 89° 15' E. 15.415 chains thence S. 13' W. 35 chains to the place of beginning.
