CERTIFICATE OF WATER RIGHT

This Is to Certify, That F. P. COLGAN

of Route 9, Box 404, Salem , State of Oregon , has made proof
to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of
Pringle Creek
a tributary of Willamette River for the purpose of
irrigation
under Permit No. 18303 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from June 23, 1948,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes
aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed
0.03 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream.
The point of diversion is located in the Lot 3 (SW $\frac{1}{4}$ SW $\frac{1}{4}$), Section 2, Township 8 South,
Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other
right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second
per acre, or its equivalent for each acre irrigated and shall be further limited
to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated
during the irrigation season of each year,

and shall
conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is
appurtenant, is as follows:

2.3 acres in Lot 3 (SW $\frac{1}{4}$ SW $\frac{1}{4}$)
Section 2

Township 8 South, Range 3 West, W. M.

Land on which water is to be used is a part of that described as follows:

Beginning at a point which is 337.57 feet E. and 704.9 feet S. 0° 21' W.
from the SE corner of the D.L.C. of F. R. Smith and wife in T. 8 S., R. 3 W.,
W. M., in Marion County, Oregon, and from thence running South 0° 21' W.
parallel with the W. boundary line of Sec. 2 in said Township and Range,
656.33 feet to the South boundary line of Lot 11, Morningside Out Lots,
Marion County, Oregon, (See Vol. 3, Page 53 Record of Town Plats for said
County and State); thence South 89° 38' East along the S. boundary line of
said Lot 11, 265.27 feet; thence North 0° 21' East parallel with the W.
boundary line of said Sec., 657.35 feet to a point 9.65 feet S. of the
N. boundary line of Lot 10 of Morningside Out Lots; thence West 265.27 feet
to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of
use herein described.
