CERTIFICATE OF WATER RIGHT

This Is To Certify, That

LOUIS A. CORWIN

of Rt. 1, Box 96, Ashland , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of two unnamed gulches and reservoir to be constructed under App. No. R-28042, Per. No. R-1475 a tributary of Bear Creek for the purpose of

irrigation and supplemental irrigation under Permit No. 22061 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 28. 1953.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.58 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE¹/₄ NW¹/₄, Section 30, Township 38 South, Range 1 East. W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed $4\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir to be constructed under Permit No. R-1475,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Beginning at a point on the South line of Lot six (6) in Block "A" of the Rogue River Valley Orchard Company's Orchard Tracts in Jackson County, Oregon, said point being N. 89° 54° East 59.97 feet from the SW corner of said Lot 6; thence N. 0° 04° West 134.0 feet; thence S. 89° 32° West 399.81 feet to the West line of Lot 7 in said Bock "A"; thence South along the West line of said Lot 7, 131.4 feet to the SW corner thereof; thence East, along the South line of said Lots 7 and 6 to the point of beginning.

ALSO, all of Lots 8, 9, 10 and 11 in said Block "A" and all that portion of Carter Lane as vacated extending from the East line of said Lot 8, to the West line of said Lot 11;

ALSO, all that part of Block "B" of said tracts, described as follows:

Lots 1, 2, 3, 4, 5, 6, 7, 8, 9, and 10.
