for the purpose of

of the State Engineer, and that said right to the use of said waters irrigation has been perfected in accordance with the laws of Oregon; that the priority of the right hereby under Permit No. confirmed dates from April 15, 1946.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.125 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE SW . Section 8, Township 29 South, Range 14 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other of one cubic foot per second right existing for the same lands, shall be limited to one-tenth per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 0.75 acre-foot for each are irrigated in any 30-day period and shall still further be limited to a diversion of not to exceed 6 acre-feet per acre during the irrigation season of each year, and shall be still further limited to a diversion of not to exceed 0.125 c.f.s.,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

> 3.01 acres in the NE SW 0.86 acres in the NW# SW# Section 8 Township 29 South, Range 14 West, W. M.

Land on which water is to be used is a part of that described as follows:

A parcel of land situated in the NW_{4}^{1} SW_{5}^{1} of Section 8, T. 29 S., R. 14 W., W. M., Coos County, Oregon. Beginning at the NE corner of the siad NW_{4}^{1} SW_{4}^{1} , thence West 100.0 feet, South 14° 28' W. 800.4 feet, East 300.0 feet, thence North 775.0 feet to beginning. Also the NE_4^1 SW_4^1 of said Section 8.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
