CERTIFICATE OF WATER RIGHT

This Is to Certify, That KENNETH and ORAL CHILDS

Route 3, Box 7, Lebanon, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of South Santiam River a tributary of Willamette River for the purpose of irrigation under Permit No. 19727 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 27, 1950.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.012 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ NW $\frac{1}{4}$, as projected within R. Cheadle D.L.C. No. 55, Section 19, Township 12 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.8 acres in Lot 2 (NE $\frac{1}{4}$ NW $\frac{1}{4}$)
0.1 acres in the NE $\frac{1}{4}$ NW $\frac{1}{4}$, as projected within
R. Cheadle D.L.C. No. 55
Section 19

Township 12 South, Range 1 West, W. M.

Land on which water is to be used is a part of that described as follows:

Beginning at the $\frac{1}{4}$ sec. corner, between Sec's. 18 and 19 in T. 12 S., R. 1 W., of the W. M., running thence West 7.50 chains; thence South parallel with the center line of Sec. 18 and 19, 13.66 chains to the north bank of the Santiam River, in T. 12 S., R. 1 W., W. M., thence Easterly along the North bank of said river 7.50 chains to a point which is directly South of the $\frac{1}{4}$ sec. corner between Sec's 18 and 19 in said Township and range; thence North 14.66 chains to the place of beginning, excepting therefrom the county road which crosses the South end of said premises, all lying and being situated in Linn County, Oregon

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
