CERTIFICATE OF WATER RIGHT

This Is to Certify, That PHILIP M. and EUNICE C. BRANDT

of Route 8, Box 522, Salem , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of two unnamed streams

a tributary of Willamette River

for the purpose of

irrigation

under Permit No. 19754 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 3, 1950,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.083 cubic foot per second, being 0.035 c.f.s. from south stream and 0.048 c.f.s. from north stream,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SN_{+}^{1} , SN_{+}^{1} , as projected within Walling D.L.C. No. 48, Seation 36, Township 6 South, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year.

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

6.8 acres in the SW $^{\frac{1}{4}}$ SW $^{\frac{1}{4}}$, as projected within Walling D.L.C. No. 48 Section 36

Township 6 South, Range 4 West, W. M.

Land on which water is to be used is a part of that described as follows:

Beginning at a point on the S. Boundary of the D.L.C. of J. D. Walling in
T. 7 S., R. 4 W., W.M. said point is N. 74° 40' East 21.18 chains from the
SW corner of said D.L.C.; thence North 15° 0' West 17.64 chains to an iron
pipe and anchor post at the NW corner of the Catton place; thence South 74° 40'
W. 9.09 chains; thence S. 15° 0' E. 17.50 chains to the North Boundary of the
private road; thence N. 74° 40' E. 4.54 chains to the County Road; thence South
15° 20' E. 38/100 of a chain; thence along the S. Boundary of said J.D. Walling
L.L.C. 4.38 chains to an iron pipe at the place of beginning, in Polk County,
Oregon, containing 15.90 acres.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
