CERTIFICATE OF WATER RIGHT

(For Rights which have been confirmed by the Courts)

This is to Certify, That D. E. GILMAN, of Heppnor, State of Oregon, 97836 has a right to the use of the waters of RHEA CREEK, tributary to Willow Creek, tributary to the Columbia River, in Morrow County, Oregon,

for the purpose of irrigation, (during the irrigation season)

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Morrow County, and the said decree entered of record at Salem, in the Order Record of the Board of Control of the State of Oregon, in Volume 1, at page 73; that the priority of the right hereby confirmed dates from 1874 for the irrigation of one hundred and seventy and five-tenths (170.5) acres and from 1879 for the irrigation of thirty-four and one-half (34 1/2) acres;

that the amount of water to which such right is entitled and hereby confirmed for the purpose aforesaid, is limited to an amount actually beneficially used for said purpose, and shall not exceed 2.84 cubic feet per second as of date 1874 and 0.58 cubic feet per second as of date 1879.

A description of the lands irrigated under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows:

Seven and one-half (7 1/2) acres in SW 1/4 of SE 1/4; Sec. 21; five (5) acres in NW 1/4 of NE 1/4; six and one-half (6 1/2) acres in SW 1/4 of NE 1/4; eleven (11) acres in NW 1/4 of SE 1/4; five (5) acres in S 1/4 of SE 1/4; Sec. 28; Tp. 3 S. R. 25 E., W. M.; twelve (12) acres in SE 1/4 of NE 1/4; seven (7) acres in NE 1/4 of SE 1/4; Sec. 8; seventeen (17) acres in NW 1/4 of SE 1/4; twenty-six (26) acres in SW 1/4 of SW 1/4; Sec. 9; two (2) acres in NE 1/4 of NW 1/4; nineteen (19) acres in NW 1/4 of NW 1/4; two and one-half (2 1/2) acres in SW 1/4 of NW 1/4; fifteen and one-half (15 1/2) acres in SE 1/4 of NW 1/4; twenty-two (22) acres in NE 1/4 of SW 1/4; fourteen (14) acres in SE 1/4 of SW 1/4; Sec. 16; one and one-half (1 1/2) acres in SW 1/4 of NE 1/4; nine (9) acres in NE 1/4 of NW 1/4; ten and one-half (10 1/2) acres in SE 1/4 of NW 1/4; two (2) acres in NE 1/4 of SW 1/4; ten (10) acres in NW 1/4 of SE 1/4; Sec. 21; All in Tp. 3 S. R. 25 E., W.M., in Morrow County, Oregon.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.
