CERTIFICATE OF WATER RIGHT

This Is to Certify, That CAROL W. & SYLVIA E. CRENSHAW

of 1082 Grove Street. Lebanon , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Thomas Creek

a tributary of South Santiar River

for the purpose of

irrigation

under Permit No. 20863 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 9, 1951,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.95 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE4 NE4, as projected within J. Thomas E.L.C. No. 47, Section 9, Township 10 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightlieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{t}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

37.6 acres in the NE¹/₄ NE¹/₄
8.4 acres in the NW¹/₄ NE¹/₄
5.2 acres in the SW¹/₄ NE¹/₄
24.4 acres in the SE¹/₄ NE¹/₄
All as projected within J. Thomas D.L.C. No. 47
Section 9

Township 10 South, Range 1 West, W. M.

Land on which water is to be used is a part of that described as follows:

Beginning at the NE corner of Sec. 9, T. 10 S., R. 1 W., W. M., running thence West 23.75 chains, thence South 33.81 chains to the center of the main channel of Thomas Creek, thence up the center of the main channel of said Creek to a point due South of the place of beginning, thence North 37.96 chains, more or less, to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
