CERTIFICATE OF WATER RIGHT

This Is to Certify, That HENRY J. BEUTLER

of Rt. 6, Box 517, Salem , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of

hast branch of Little Pudding River a tributary of Pudding River

for the purpose of

irrigation
under Permit No. 22049 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from January 22. 1953,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.21 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE SW as projected within Woodworth D.L.C. No. 59, Section 10, Township 7 South, Range 2 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.3 acres in the SW: NE; 0.8 acres in the SE: NE; 5.6 acres in the NE; SE: 9.2 acres in the NW: SE;

All as projected within Woodworth P.L.C. No. 59 Section 10

Township 7 South, Range 2 West, W. M.

Land on which water is to be used is a part of that described as follows: Beginning at the SW corner of the F. N. Woodworth D.L.C. No. 59; thence North 20.23 chains; thence East 34.40 chains; thence South 0° 30' West 20.02 chains to a point 31 links North of the South line of said Woodworth D.L.C.; thence East 9.50 chains; thence South 31 links to the South boundary line of said D.L.C. No. 59; thence West along the South boundary line of said D.L.C. No. 59, 43.65 chains to the place of beginning and being a part of the D.L.C. of F. N. Woodworth No. 59, in T. 7 S., R. 2 V., W. M., in Marion County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
