under Permit No. 17860 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 7. 1947.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.185 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW. SW. as projected within E. T. Grubb D.L.C. No. 59, Section 19, Township 26 South, Range 6 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited tone-eightieth of one cubic foot per second per acrept its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be used is a part of that described as follows: Lots 2 and 3. Block 11-Roseburg Home Orchard Tracts being within Sec. 19. T. 26 S., R. 6 W., W. M.

This certificate is issued to correct and supersede that certain water right certificate i sued on the 2nd day of March, 1956 and recorded in State Record of Water Right Certificates, Vol. 15, page 21071, so as to correctly show the source of water as being the Umpqua River.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
