This Is to Certify, That J. D. ANDERSON

of Box 52, Wecoma , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed spring

for the purpose of

domestic for one family and irrigation

under Permit No. 16896 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 10, 1946

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.02 cubic foot per second, being 0.01 cubic foot per second for domestic and 0.01 cubic foot per second, for irrigation.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 27 (SE SW4), Section 2, Township 7 South, Range 11 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year.

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Domestic & O.9 acres in Lot 27 (SE¹ SW¹₄) Section 2 Township 7 South, Range 11 West, W.M.

Beginning at the SW corner of the SE¹/₄ SW¹/₄, Sec. 2, T 7 S., R 11 W., W.M.; running thence North 0° 26 Min. West on 1/16 section line 540.89 feet to North boundary of Holmes county road; thence North 72° 58' east along the north boundary of Holmes county road 11.93 feet to initial point of this tract; running thence North 0° 26' West 350.0 feet; thence North 72° 58' East 375.0 feet; thence South 0° 26' East 350.0 feet to North boundary of the Holmes county road; thence South 72° 58' west along the north boundary of road 375.0 feet to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
