## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That SCHUYLER L. FLETCHER

of Route 3, Box 170, Tillamook , State of Oregon ,, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Munson Creek

a tributary of Tillamook River

for the purpose of

irrigation
under Permit No. 17828 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from June 11, 1947

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.22 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE<sup>1</sup> NE<sup>1</sup>, Section 29, Township 2 South, Range 9 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year.

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

6.2 acres in the  $NE_{\frac{1}{4}}^{\frac{1}{4}}NE_{\frac{1}{4}}^{\frac{1}{4}}$  0.1 acres in the  $NW_{\frac{1}{4}}^{\frac{1}{4}}NE_{\frac{1}{4}}^{\frac{1}{4}}$  1.6.8 acres in the  $SE_{\frac{1}{4}}^{\frac{1}{4}}NE_{\frac{1}{4}}^{\frac{1}{4}}$  Section 29

Township 2 South, Range 9 West, W.M.

Land on which water is to be used is part of the property described as follows:

Beginning 14 chains South of the Northeast corner of Section 29, Township 2 South, Range 9 West of the Willamette Meridian., thence West to the Tillamook River, thence upstream along said River to a point 17 chains West of the East line of Section 19, thence North 5 chains, thence East to the East line of Section 19, thence North to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
