CERTIFICATE OF WATER RIGHT

(For rights perfected under original, enlargement or secondary permits)

This is to Certify, That A. CRELSON

of Roseburg, State of Oregon, has made proof to the satisfaction of the STATE WATER BOARD of Oregon, of a right to the use of the waters of Mill Creek, tributary of Bridge/ ~~xxxxxxxxxx~~ Wood Camp Creek, a tributary of John Day River, for the purpose of the irrigation of 86.18 acres of land

under Permit No. 2576 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon and duly confirmed by order of the STATE WATER BOARD of Oregon, made and entered

of record in the Record of Proceedings of said Board, at Salem, in Volume 1, at page 301, on the 20th day of November, 1918; that the priority of the right hereby confirmed dates from July 28, 1915; that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not

exceed 1.10 cubic feet per second, or its equivalent in case of rotation. The use hereunder shall conform to any reasonable rotation system ordered by the proper State Officer.

A description of the lands under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows: 7.43 acres in the SE 1/4 SE 1/4; 3.45 acres in the NE 1/4 SE 1/4 Section 13, Township 12 South, Range 21; 0.60 acre in the NW 1/4 SW 1/4; 5 acres in the NW 1/4 NW 1/4; 4.99 acres in the NE 1/4 NW 1/4; 7.88 acres in the NW 1/4 NE 1/4; 0.56 acre in the SE 1/4 NE 1/4 and 3.41 acres in the NE 1/4 NE 1/4 of Section 18; 9.38 acres in the SW 1/4 SW 1/4; 19.87 acres in the SE 1/4 SW 1/4; 2.88 acres in the NE 1/4 SW 1/4; 0.62 acre in the NW 1/4 SW 1/4; 6.68 acres in the SW 1/4 SE 1/4 of Section 7; 0.37 acre in the NE 1/4 NE 1/4 of Section 20; 2.35 acres in the SW 1/4 SE 1/4; 6.40 acres in the SE 1/4 SW 1/4; 2.05 acres in the NE 1/4 SW 1/4; 0.35 acre in the NW 1/4 SW 1/4; 2.11 acres in the SW 1/4 NW 1/4 of Section 17, Township 12 South, Range 22, All East of Willamette Meridian, in Wheeler County, Oregon.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.

Rights to the use of water for power purposes are limited to a period of forty years from the date of priority of the right, as herein set forth, subject to a preference right of renewal under the laws existing at the date of the expiration of the right for power purposes, as hereby confirmed and limited.
