**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That . N. C. PEARSON**

of Rt. 1, Box 557, Oregon City, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of unnamed stream a tributary of Beaver Creek for the purpose of irrigation under Permit No. 19711 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 21, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.025 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$  NE $\frac{1}{4}$ , Section 13, Township 3 South, Range 1 East, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year.

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows: 2.0 acres in the SW $\frac{1}{4}$  NE $\frac{1}{4}$

Section 13  
Township 3 South, Range 1 East, W.M.

Land on which water is to be used is part of that described as follows: Part of the S. White D.L.C. #42, in section 13, and part of section 13, in T. 3 S., R. 1 E., of the W.M. described as: "Beginning at the southeast corner of S.S. White D.L.C. #42, in T. 3 S., R. 1 E. of the W.M., thence N. 47° 30' W. 40.00 chains to the southwest corner of said claim; thence N. 42° 30' E. 9.60 chains on the northwest line of said claim, which point is marked by an iron pipe; thence on a compromise line as described in book 259 of deeds at page 690, S. 45° 45' E. 1170.5 feet to an iron pipe; thence on said compromise line S. 89° 01' E. 1201.4 feet to an iron pipe on the east line of land formerly owned by Carrie Pettinger, as described in estate #7327, records of Clackamas County, Oregon; thence S. 1° 30' W. 8.30 chains; thence S. 5° 30' W. 5.24 chains; thence West 1.40 chains to the southeast line of claim #42 aforesaid; thence S. 42° 30' W. on claim line 8.08 chains to the place of beginning, containing 49.75 acres more or less."

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
