## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That . ED HARTWELL BERGIN

of Rt. 2, Box 304, Beaverton , State of Oregon . , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Rock Creek

a tributary of Tualatin River

for the purpose of

irrigation

under Permit No. 19958 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 13, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SEA NEA, Section 4, Township 1 South, Range 2 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year.

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.0 acre in the SE<sup>1</sup> NE<sup>1</sup> Section 4
Township 1 South, Range 2 West, W.M.

Legal description: about 11 acres more or less located in SE1 of Sec. 4 and a part of tract 13 chism and a part of Brookwood T. 1 S., R. 2 W., W.M., beg. at the NW corner of Lot 13, chism a duly recorded subdivision in Washington County, Oregon, thence N. along E. line of lot 20 Brookwood to the SE corner of that certain tract conveyed to E. F. Gosser and wife, Thence W. 21.4 ft. to the center of Rock Creek, thence SW in the center of said Rock Creek to the NW corner of that certain tract conveyed to Donald L. Eagon and wife. Thence E. on the N. line of said Eagon tract to the NE corner thereof. Thence, N. along the W. line of that certain tract conveyed to Donald H. Eagon, and wife a distance of 223 ft. to the N. line of lot 13 chism, thence W. 89 ft. to the place of beginning. Being a portion of lots 19 & 20 Brookwood and a part of lot 13 chism according to the duly recorded maps and plots thereof.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
