under Permit No. 19351 of the State Engineer, and that said right to the use of said waters

under Permit No. 19354 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from Narch 17, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.05 cubic foot per second and 2,500,000 gallons stored water, being 0.05 cubic foot per second for domestic use for 7 families and meat processing from Creek and reservoir and 2,500,000 gallons stored water only for manufacturing and fire protection.

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the SWA NEA, Section 8, Township 1 South, Range 9 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ------ of one cubic foot per second per acre,

conform to such reasonable rotation system as may be ordered by the proper state officer.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
