CERTIFICATE OF WATER RIGHT

This Is to Certify, That E. E. COLVIN

of 1426 Jackson Street, Corvallis, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Siletz River a tributary of Pacific Ocean for the purpose of irrigation under Permit No. 21904 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 24, 1952

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.42 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in ~~the~~ Lot 12 (SE $\frac{1}{4}$ NW $\frac{1}{2}$), Section 4, Township 10 South, Range 10 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year and shall be still further limited to a diversion of not to exceed 0.42 cubic foot per second.

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.8 acres in Lot #10 (SW $\frac{1}{4}$ NW $\frac{1}{2}$)
4.6 acres in Lot #11 (SE $\frac{1}{4}$ NW $\frac{1}{2}$)
4.2 acres in Lot #12 (SE $\frac{1}{4}$ NW $\frac{1}{2}$)
16.4 acres in Lot #21 (NE $\frac{1}{4}$ SW $\frac{1}{2}$)
19.2 acres in Lot #22 (NE $\frac{1}{4}$ SW $\frac{1}{2}$)
4.4 acres in Lot #23 (NW $\frac{1}{4}$ SW $\frac{1}{2}$)
1.8 acres in Lot #27 (SE $\frac{1}{4}$ SW $\frac{1}{2}$)
1.4 acres in Lot #28 (SE $\frac{1}{4}$ SW $\frac{1}{2}$)
Section 4

Township 10 South, Range 10 West, W.M.

That part of the East 6 chains of Lot 10, and Lots 11 and 12, lying South of the Siletz River, Lots 21 and 22, the East $\frac{1}{2}$ of Lot 23 and the North 2 $\frac{1}{2}$ chains of Lots 27 and 28 in T 10 S., R 10 W., W.M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
