Route 1, Banks State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Garrigus Creek for the purpose of

of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby

confirmed dates from February 27, 1953

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.017 cubic foot per second, being 0.01 cubic foot per second for domestic and

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE4 SE4, Section 14, Township 2 North, Range 4 West, W.H.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year.

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

s: 1/8 acre in the SE $\frac{1}{4}$ SE $\frac{1}{2}$ Domestic and 1/8 acre in the SW $\frac{1}{4}$ SE $\frac{1}{4}$

Township 2 North, Range 4 West, W.N.

Part of Section 14, T. 2 N., R. 4 W., of Willamette Meridian.

Beginning at the intersection of the east line of the S. W. 1 of Sec. 14 with the Southerly boundry of County road, thence South along the East line of the S. W. 4 of SET of said Sec. 65 ft. thence west 50 ft; thence North parallel with the east line of the S.W.; of the S.E. of said section the Southerly boundary of the County road; thence Southerly along the Southerly boundary of the County road to the point of begining.

Our garden is just over the line on the SEA of the S.E. of Sect. lh. on property belonging to Earl Caldwell and John R Caldwell. (Brothers & Partners) in business.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
