CERTIFICATE OF WATER RIGHT

This Is to Certify, That **MARTHA PIGMAN**

of Bay City , State of Oregon , has made proof
to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of
Kilchis River
a tributary of Tillamook Bay for the purpose of
irrigation
under Permit No. 22501 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from June 5, 1953

that the amount of water to which such right is entitled and hereby confirmed, for the purposes
aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed
0.34 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream.
The point of diversion is located in the NW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 7, Township 1 South, Range 9
West, W.M.

The amount of water used for irrigation, together with the amount secured under any other
right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second
per acre, or its equivalent for each acre irrigated and shall be further limited to
a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during
the irrigation season of each year, and shall be still further limited to a diver-
sion of not to exceed 0.34 cubic foot per second.

and shall
conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is
appurtenant, is as follows:

19.7 acres in the NW $\frac{1}{4}$ SW $\frac{1}{4}$
9.4 acres in the NE $\frac{1}{4}$ SW $\frac{1}{4}$
Section 7
Township 1 South, Range 9 West, W.M.

Land on which water is to be used is part of the property described as follows:

The S $\frac{1}{2}$ of the N $\frac{1}{2}$ of the SW $\frac{1}{4}$ of Section 7, T 1 S., R 9 W., W.M., and also tract
Beginning South 313.5 feet from the $\frac{1}{4}$ Section corner common to Section 7, T 1 S.,
R 9 W., W.M., and Section 12, T 1 S., R 10 W., W.M., thence East 76 rods and 4 feet
(1280.0 feet) and thence South 21 rods, (346.5 feet) thence West 76 rods and 4 feet;
thence North 21 rods to the Place of Beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of
use herein described.
