## CERTIFICATE OF WATER RIGHT

This Is To Certify, That BLOON F., EUGENE D. AND WANDA L. HARCIS

of Powell Butte , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of

Old River Bed a tributary of Crooked River

for the purpose of

irrigation under Permit No. 18675 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 18, 1945

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.10 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SEL NEL Section 10, Township 15 South, Range 11 East, W.K.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 1.0 acre feet per acre for each acre irrigated during the irrigation season of each year.

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be used is part of the property described as follows: Beginning at the SW corner of the NW\(\frac{1}{2}\) of Section 11, Township 15 South, Range 14 East of the W.M., thence East 450 ft., thence North 810 ft., thence 30 ft. West, thence North 1285 ft., thence West 500 ft., thence South 2380 ft. in a meandering direction following the hill, thence East 350 ft. to point of beginning, containing 31\(\frac{1}{2}\) acres more or less. Beginning at a point 2640 ft. North from the SW corner of the NW Quarter of Section 11, Township 15 South, R 14 East of the Willamette Meridian, thence North 1200 ft., thence West 600 ft., thence South 1350 ft., thence East 600 ft., thence North 150 ft., to point of beginning, Containing 18\(\frac{1}{2}\) acres, more or less. Beginning at a point 2270 ft. West from the SW corner of the NW quarter of Section 11, Township 15 South, Range 14 East of the Willamette Meridian, thence North 5280 ft. in a meandering direction following the hill, thence West 650 ft., thence South 5280 ft. in a meandering direction to the hill, thence East 650 ft. to point of beginning. Containing 80 acres, more or less. All located in Crook County, Oregon.
