## CERTIFICATE OF WATER RIGHT

## This Is To Certify, That C. R. COLEE

, has made proof State of Oregon to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Crooks Creek

a tributary of Deer Creek

for the purpose of

irrigation of the State Engineer, and that said right to the use of said waters under Permit No. 19557 has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 8, 1950.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.20 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SN + NN +, Section 9, Township 38 South, Range ? West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands. shall be limited to one-fiftieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $3\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

9.7 acres in the NE $\frac{1}{7}$  SE $\frac{1}{7}$ , as projected within D.L.C. No. 42 4.3 acres in the NE $\frac{1}{7}$  SE $\frac{1}{7}$  (Lot 7)

21.0 acres in the SE SE, as projected within D.L.C. No. 42 Section 8

6.0 acres in the SNI NWI

7.0 acres in the Mi SNE (Lot 10)

3.0 acres in the NW SW as projected within D.L.C. No. 42

9.0 acres in the SW SW , as projected within D.L.C. No. 42 Section 9

Township 38 South, Range 7 West, V. M.

Land on which water is to be used is a part of that described as follows:

That part of the Swit Nwit, Sec. 9, lying S. of the County Road, in T. 38 S., R. 7 W., W. M. Also Gov. Lot 10 in Sec. 9, of said township and range. Also the  $W_2^1$  of D.L.C. No. 42 in said Sec. 9, and Sec. 8 of said township and range. That part of Gov. Lot No. 7, lying southerly and easterly of the County Road in Sec. 8, T. 38 S., R. 7 W., W. M.

This certificate is issued to correct and supercede that certain water right certificate issued on October 30, 1952, and recorded in State Record of Water Right Certificates, Volume 14, Page 20208, so as to correctly show the place of use.
