CERTIFICATE OF WATER RIGHT

This Is to Certify, That HAROLD FOGG

of Route 3, Box 127, Tillamook, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Killam Creek a tributary of Tillamook River for the purpose of irrigation under Permit No. 19844 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 15, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.4 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within L. Killam DLC 38, Section 16, Township 2 South, Range 9 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

5.8 acres in the SW $\frac{1}{4}$ NE $\frac{1}{4}$ as projected within Killam DLC 38
24.8 acres in the NW $\frac{1}{4}$ SE $\frac{1}{4}$ as projected within Killam DLC 38
1.7 acres in the NE $\frac{1}{4}$ SE $\frac{1}{4}$ as projected within Killam DLC 38
Section 16
Township 2 South, Range 9 West, W. M.

Land on which water is to be used is part of that described as follows:

The south fifty acres, more or less, of the following tract of land: Beginning at a point 20 feet south and 73 rods west of the NE corner of the Leonard Killam DLC in Sec. 16, T 2 S., R 9 W., W.M. and running thence W. to the center of the present county road, running N. and S. through said DLC, thence S. to a point one rod N. of the S. line of said DLC: thence E, to a point 73 rods W. of the E. line of the Killam DLC: thence N. to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
