under Permit No. 19887 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 24, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SEASWA, Section 18, Township 3 South, Range 9 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to—————— of one cubic foot per second per acre,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows: $SW_{A}^{1}SE_{A}^{1}$

Land on which water is to be used is part of that described as follows:

Beginning at a point which is 654.10 feet North and 1099.69 feet West of the Southeast corner of the SWA SEA, Sec. 18, T 3 S., R 9 W., W. M., Tillamook, Oregon; said point also being in the center of the State Highway 101, and in the center of a small culvert; thence West 553.0 feet; thence North 9-44 West 304.88 feet; thence North 45-00' East 447.27 feet to a hub on the North bank of a small creek and the North line of the SEASWA; thence East 89-30' East 191.64 feet to the center of the State Highway; thence following said State Highway South 21-21' East 53.72 feet; thence following a 764. feet radius curve to the right whose long chord bears South 11-16' East 267.52 feet; thence following a 382. feet radius curve to the left whose long chord bears South 10-39' East 112.45 feet to the place of beginning; containing 6.44 acres more or less and being situated in the SWA SEA of and the SEA SWA of Sec. 18, T 3 S., R 9 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
