CERTIFICATE OF WATER RIGHT

This Is to Certify, That JAMES. E. & DORIS H. WADDELL

of Route 1, Box 27, Ashland , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a spring a tributary of Bear Creek Watershed for the purpose of domestic use, including the irrelation of not to exceed a acre garden under Permit No. 20659 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 16, 1951

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SEASEA, Section 31, Township 38 South, Range 1 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ----- of one cubic foot per second per acre,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be used is part of that described as follows:

M. thence N. 65° 15' W. 886.9 ft.; thence N. 37° 37' E. 58.4 ft. to the point of beginning, thence S. 37° 37' W. 353 ft.; thence S. 68° 42' W. 322 ft.; thence N. 83° 12' W. 274.2 ft.; thence N. 49° 10' E. 1533.7 ft.; thence S. 57° 33' E. 210.4 ft.; thence S. 18° 57' W. 271; thence S. 54° 57' W. 320.5 ft. S. 72° 37' W. 217.7 ft. more or less to the place of beginning. Also beginning at the same point: thence S. 37° 37' W. 353 ft.; thence S. 64° 42' W. 322 ft.; thence S. 21° 15' W. 140 ft.; thence S. 16° 04' E. 100 ft.; thence N. 53° E. 722 ft.; thence N. 64° 24' E. 82 ft.; thence S. 78° 42' E. 74.3 ft.; thence N. about 34° W. 263 ft. more or less; thence S. 72° 37' W. 56 ft. to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
