a tributary of Yamhill River for the purpose of

irrigation

under Permit No. of the State Engineer, and that said right to the use of said waters 20919 has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 20, 1951

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.65 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE ASEA, as projected within Palmer DLC #80, Section 20, Township 4 South, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 21 acre feet per acre for each acre irrigated during the irrigation season of each year.

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

6.3 acres in the SWINE as projected within Palmer DLC #80

0.1 acres in the NEISE as projected within Palmer DLC #80

2.4 acres in the NEISEI as projected within Goodrich DLC #49

3.5 acres in the NW4SE4 as projected within Goodrich DLC #49
35.5 acres in the NW4SE4 as projected within Palmer DLC #80
3.4 acres in the SW4SE4 as projected within Palmer DLC #80
0.2 acres in the SW4SE4 as projected within Goodrich DLC #49

0.3 acres in the SEISEI as projected within Goodrich DLC #49 Section 20

Township & South, Range 3 West, W. M.

Land on which water is to be used is part of that described as follows:

Beginning at a point 14 chains, North of the Southwest corner of Joel Palmor DLC #80, in Section 20 Township 4 South, Range 3 West, W.M., thence North 23 chains, thence East 7 chains, thence North 3 chains, thence East 15 chains, thence South 26 chains, thence west 22 chains to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of

use herein described.
