CERTIFICATE OF WATER RIGHT

This Is to Certify, That, PERCY R. CALKINS

of Route 1, Sox 210, Otis , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed stream

a tributary of Salmon River, a tributary of the Pacific Ocean for the purpose of irrigation and domestic use for 2 families

under Permit No. 16675 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 15, 1915

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.05 cubic foot per second, being 0.03 cfs for irrigation and 0.02 cfs for domestic

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE SW4, Section 33, Township 6 South, Range 10 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, a d to which such right is appurtenant, is as follows: 2.3 acros & domestic in the $SE_4^1NN_4^1$ Section 33

Township 6 South, Range 10 West, W. M.

Lend on which water is to be used is part of that described as follows:

Beginning at a point that is 335 ft. south and hho ft. east of NW corner, SENW1, of Section 33; thence south 22° 8' West 911.8 ft. more or less to State Highway; thence North west along said Highway 125 ft.; thence south 220 ft. to the SW corner of said SE1NW1; thence east 258.6 ft.; thence North 55° 00' east 764 ft. more or less to the west bank of Salmon River; thence in a northwesterly direction along west bank of said river to a point that is due east of the place of beginning; thence west 250 ft. more or less to the place of beginning. Also beginning at a point 335.0 ft. South of NW corner of the SE1NW1; Section 33; thence South 765.0 ft. to the Northerly margin of the present Salmon River State Highway; thence South 18° 30' East along the Northerly margin of said State Highway 125.0 ft.; thence North 21° 36' East 911.8 ft.; thence West 140 ft. to the point of beginning, all in Sec. 33, T 6 S., R 10 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
