CERTIFICATE OF WATER RIGHT

This Is to Certify, That LOUISE B. & WARREN A. MCMINIMEE

of Tillamook Building, Tillamook , State of Oregon . , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Donaldson Creek

a tributary of Hueghy Creek & Wilson River

for the purpose of

irrigation & operation of hydraulic ram

under Permit No. 211:32 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 26, 1952

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.03 cubic foot per second, being 0.01 cfs for irrigation & 0.02 cfs for operation of hydraulic ram

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 13 (SWINI) Section 23 (WVINI) Section 26, Township 1 South, Range 9 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightleth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.0 acres in the SW Lot 13 (SW SW TO Section 23
Township 1 South, Range 9 West, W. M.

Land on which water is to be used is part of that described as follows:

Starting at the sec. corner common to Sec. 22, 23, 26 & 27, T. 1 S., R 9 W., W. M., and running thence along said Sec. line approximately 693 ft. to a point 25 ft. E. of the center of Donaldson Creek; thence Northwesterly paralleling and 25 ft. E. from the center of Donaldson Creek to a point 300 ft. N. and 131 ft. E. of said Sec. corner; thence W. 131 ft. to the Sec. line between said Sec. 22 and 23: thence S. 300 ft. to the place of beginning, all in Sec. 23, T. 1 S., R 9 W., W. M.,

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
