**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** MR. ROD NEWCOMB

of Route 2, Dayton, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed stream a tributary of Yamhill River for the purpose of irrigation under Permit No. 21627 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 21, 1952

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.038 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ SE $\frac{1}{4}$ , Section 8, Township 4 South, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.25 acres in the SW $\frac{1}{4}$ SE $\frac{1}{4}$   
Section 8  
.75 acres in the NW $\frac{1}{4}$ NE $\frac{1}{4}$   
Section 17  
Township 4 South, Range 3 West, W. M.

Land on which water is to be used is part of that described as follows:

A tract of land in the Stewart Hanna DL3 in T 4 S., R 3 W., of the W. M., in Yamhill County, Oregon, described as follows:  
Beginning at a point in the center of the County Road at the most Easterly S.E. corner of that certain tract of land conveyed by deed to Harry John Stewart and recorded in book 109, page 671 of Deed Records of Yamhill County, Oregon; thence running N. 80° 12' West 380'; N. 8° 03' E. 400'; S. 80° 12' E. 380' to the center of the County Road; S. 8° 08' W. following the center of road to the place of beginning; excepting therefrom that portion included in said County Road.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
