CERTIFICATE OF WATER RIGHT

This Is to Certify, That MILLARD BAILEY

of Route 1, Box 137, Bay City , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Kilchis River

a tributary of Tillamook Bay

for the purpose of

irrigation

under Permit No. 22940 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 14, 1954

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.36 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW 15W2, Section 7, Township 1 South, Range 9 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

5.6 acres in Lot $4 \left(\text{SW}_{\frac{1}{2}}^{\frac{1}{2}} \text{NW}_{\frac{1}{2}}^{\frac{1}{2}} \right)$ 3.1 acres in Lot 3 $\left(\text{SE}_{\frac{1}{2}}^{\frac{1}{2}} \text{NW}_{\frac{1}{4}}^{\frac{1}{2}} \right)$ 10.4 acres in the NE $\frac{1}{3}$ SW.

9.3 acres in the NW-SW-

Section 7

Township 1 South, Range 9 West, W. M.

Land on which water is to be used is part of that described as follows:

Beg. at a point which is 305 ft. N. of the W½ corner, Sec. 7, T. 1 S., R. 9 W., W. M. Tillamook County, Oregon. Thence E. 360.6 ft.; thence S. 90.9 ft.; thence N. 89° 54' E. 1534.0 ft.; thence N. 78° 59' E. 378.2 ft.; to the N. bank of Kilchis River; thence N. 51° 41' E. 380 ft. along the Kilchis River to the ½ line in the center of Sec. 7; thence S. 1162.3 ft.; thence S. 88°39' W. 1310.7 ft.; thence N. 3141.1 ft.; thence S. 88° 57' W. 1252.4 ft. to the center of the County Road; thence N. 619 ft. to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
