**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** SCHOOL DISTRICT #9C

of P. O. Box 509, Coos Bay, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a spring a tributary of Millicoma River for the purpose of use in school under Permit No. 21939 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 15, 1952

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 12, (NW $\frac{1}{4}$ NE $\frac{1}{4}$ ), Section 8, Township 25 South, Range 11 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to \_\_\_\_\_ of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Lot 12 (NW $\frac{1}{4}$ NE $\frac{1}{4}$ )  
Lot 11 (SW $\frac{1}{4}$ NE $\frac{1}{4}$ )  
Section 8

Township 25 South, Range 11 West, W. M.

Land on which water is to be used is to be used is part of that described as follows:

Beginning at a point on the State Highway Right of Way N 66° 03 $\frac{1}{2}$ ' W 2671.0 ft. from the NW corner Sec. 8, T. 25 S., R. 11 W., W. M.; thence N 35° 21' E a distance of 7.33 ft. to an iron pipe; thence continuing N 35° 21' E a distance of 313.07 ft. to an iron pipe, thence S 89° 05' E for a distance of 278.05' to an iron pipe; S 36° 33' E a distance of 516.85' to the point of beginning of a curve to the right of 161.0 foot radius; thence along said curve thru a central angle of 158° 38' for a distance of 445.72 ft.; thence N 57° 55' W for a distance of 230.36 ft. to the point of beginning of a curve to the right of 1402.50 foot radius; thence along said curve thru a central angle of 5° 11' for a distance of 128.09 ft.; thence N 52° 39' W for a distance of 321.89 ft. to the point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
