## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That L. E. WELTNER

Tidewater , State of , has made proof of Oregon to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Mill Creek a tributary of Alsea River

irrigation & domestic use for 4 houses

for the purpose of

under Permit No. 15343 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 30, 1942

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0,02 cubic foot per second being 0.01 cfs for irrigation and 0.01 cfs for domestic

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SEINE 1, Section 28, Township 13 South, Range 10 West. W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 22 acre feet per acre for each acre irrigated during the irrigation season of each year.

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be used is part of that described as follows:

M., thence N. 39° 05' W. 225 ft., thence S. 49° 00' W. 49 ft., thence N. 39° 05' W. 297 ft., thence N. 37° 00' E. 67 ft., thence N. 40° 30' W. 50 ft., thence N. 37° 00' E. 200 ft., thence S. 65° 00' E. 551.7 ft., thence S. 6° 30' W. 506 ft., thence N. 55° 00' W. 79 ft., thence S. 83° 00' W. 67.6 ft., thence N. 17° 00' W. 79 ft., thence S. 83° 00' W. 67.6 ft., thence N. 47° 00' W. 100 ft. to place of beginning, containing 32 acres, more or less,
