CERTIFICATE OF WATER RIGHT

This Is to Certify, That EMIL JOHNSON

of Gates , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed spring a tributary of N. Santiam River for the purpose of domestic use for 1 family, including irrigation of $\frac{1}{2}$ acre under Permit No. 18655 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 18, 1949

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the $NE_{4}^{1}NE_{4}^{2}$, Section 34, Township 9 South, Range 3 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ---- of one cubic foot per second per acre,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is

appurtenant, is as follows:

NE 4NE 4 Section 34 Township 9 South, Range 3 East, W. M.

Land on which water is to be used is part of that described as follows:

Beginning at a point 108 ft. S. & 270 ft. W. from the corner of Sec. 26, 27, 34 & 35, in T. 9 S., R. 3 E., W.M., Linn County, Oregon, said point being 20 ft. E. of the side of a private roadway; thence following said roadway at 20 ft. distance on the following traverse: N. 35° 20' W. 226 ft.; thence S. 76° 35' W. 162 ft.; thence N. 67° 35' W. 90 ft.; thence S. 67° 25' W. 145 ft.; thence leaving roadway N. 66° W. 241 ft. to the left bank of the North Santiam River; thence following said left bank in an easterly direction upstream to a point 250 ft. W. of the line between Sec. 26, and 27 in said Twp. and Range; thence S. 460 ft. to a point 108 ft. S. & 250 ft. W. of said section corner thence W. 20 ft. to point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
