CERTIFICATE OF WATER RIGHT

This Is to Certify, That **ULRICH WYSS, JR.**

of **Cloverdale**, State of **Oregon**, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of **Walter Creek and West Beaver Creek** a tributary of **Beaver Creek** for the purpose of **irrigation, domestic use for 1 house, & stock** under Permit No. **20722** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **September 6, 1951**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.32 cubic foot per second, being 0.02 cfs from Walter Creek for domestic & stock & 0.30 cfs from W. Beaver Creek for irrigation**

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **NE $\frac{1}{4}$ SE $\frac{1}{4}$ & NW $\frac{1}{4}$ SE $\frac{1}{4}$** , Section 12, Township 3 South, Range 10 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **2 $\frac{1}{2}$ acre feet per acre** for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.8 acres in the SW $\frac{1}{4}$ NE $\frac{1}{4}$
2.4 acres in the SE $\frac{1}{4}$ NE $\frac{1}{4}$
21.4 acres, domestic & stock in the NE $\frac{1}{4}$ SE $\frac{1}{4}$
5.6 acres, domestic & stock in the NW $\frac{1}{4}$ SE $\frac{1}{4}$
Section 12
Township 3 South, Range 10 West, W. M.

Land on which water is to be used is part of that described as follows:

Those parts of the SE $\frac{1}{4}$ NE $\frac{1}{4}$ and the E. 6 chains of the NE $\frac{1}{4}$ NE $\frac{1}{4}$ and W 3/4 NE $\frac{1}{4}$ SE $\frac{1}{4}$ lying S. of the Sand Lake Road and the E. 6 chains of the NW $\frac{1}{4}$ SE $\frac{1}{4}$ all in Sec. 12, T. 3 S., R. 10 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
