CERTIFICATE OF WATER RIGHT

This Is to Certify, That J. H. & MARY E. WILLIAMS

of Route 2, Box 594 M, Mosa , State of Arizona , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of springs & reservoir constructed under App. No. R-20960, Permit No. R-818 a tributary of for the purpose of

domestic use for 1 family and irrigation
under Permit No. 16407 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from July 12, 1945

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SWINVI, Section 26, Township 13 South, Range 11 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows: $\frac{1}{2}$ acre & domestic in the $SW_{\frac{1}{4}}NW_{\frac{1}{4}}$ Section 26

Township 13 South, Range 11 West, W. M.

Lend on which water is to be used is part of that described as follows:
A part of Gov't. Lot 8 in Sec. 26, T 13 S., R 11 W., W.M., in the County of Lincoln and State of Oregon, described as follows: Beginning on the S. line of the Alsea R. Highway at a point 55 ft. E. from a concrete monument at Highway Station 146+72.2 said point being the NE corner of the Bathurst-Clay tract described in deed recorded in Book 104, page 334, Deed Records; thence S. on the E. line of said Bathurst-Clay tract 812.5 ft. more or less to the S. line of said Gov't. Lot 8; thence E. along the S. line of the said Gov't. Lot 8 a distance of 200 ft. to the SW corner of the L. F. Dornhecker tract described in deed recorded in Book 115, page 624 Deed Records; thence N. along the W. line of said Dornhecker tract 612.5 ft.; thence E. 50 ft. along the said Dornhecker tract line; thence N. along the said Dornhecker tract line 200 ft. to the Southerly line of afore-mentioned highway; thence Westerly along the Southerly line of the highway to the point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
